

**Your Weekly Writing Challenge: Marriage Equality—What Now? - Terms  
& Conditions**

1. Information on how to enter & prizes form part of these terms & conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is open to residents of Australia who are aged 12 years or older and who are not an employee of the Promoter or the Promoter's related companies, and any agencies associated with this promotion and their immediate families (including spouse, defacto spouse, parent, child or sibling (whether full, half, step or by adoption).
